BALLOT PROPOSITIONS:

- Prop 133**—Requires partisan primary elections for partisan offices.
- Prop 134**— Makes it much harder to get citizen initiatives on the ballot.
- Prop 135**— Restricts the Governor’s ability to declare a state of emergency.
- Prop 136**—Allows any person to sue to invalidate a citizen’s initiative before it is placed on ballot.
- Prop 137**—Ends term limits for State Superior & Supreme Court justices, removing citizen input.
- Prop 138**—Reduces wages for tipped workers.

**Prop 139—Establish a state constitutional
 right to abortion**

- Prop 140**—Establishes seemingly beneficial open primaries, but risks giving the legislature too much power to interfere with the process.
- Prop 311**—Requires criminal conviction fees for unrelated deaths that are already heavily compensated, penalizing people for acts they never caused.
- Prop 312**—Property tax refunds for non-enforcement of public nuisance & homelessness laws, draining municipal funds.
- Prop 313**—Poorly drafted sex trafficking law. Harsh sex offender laws already exist. Could be misapplied, sending victims to jail for life.
- Prop 314**—Revival of AZ’s failed “show me your papers” law. Unfunded mandate that would hurt business and state economy.
- Prop 315**—Takes the decision-making power out of the hands of experts in state agencies and gives it to legislators.
- Prop 479**—(Yavapai County) Adjust the annual expenditure limit base by \$7.9M at no cost to residents
- Prop 482**—(Coconino County) Adjust the annual expenditure limit base by \$7.7M at no cost to residents.
- Prop 483**—(Sedona City Limits) Uphold city zoning ordinance to allow Safe Place To Park Program.
- Question—SOCJUSD #9** Sedona Oak Creek Unified School District authorization to sell, lease or exchange the Big Park Community School in the Village of Oak Creek.
